ALERT FOR LIGHT COMMERCIAL AIR CONDITIONERS (LCAC)

2nd September, 2021

All manufacturers/permittees of LCAC under S&L program of BEE are hereby informed that the validity of existing star rating table for LCAC under voluntary regime has been extended till **31st December, 2022**.

Also, kindly note that the Star Labeling program for LCAC is proposed to be made mandatory from 1st January, 2023 and all manufacturers are therefore requested to develop requisite infrastructure and seek NABL/ILAC accreditation for in-house test set up as appropriate.

All manufacturers of LCAC who wish to apply for a grant of BEE star label from the date of issue of this alert shall apply with revised sample label validity period as 2nd March, 2020 to 31st December, 2022 and accordingly, the approval granted would be valid till 31st December, 2022.

For models already approved by BEE, the manufacturers/permittees have to submit the proforma enclosed with this Alert seeking willingness to continue the registered models with BEE beyond 31st December, 2021.

Please note that the revised sample label validity period would be from 2nd March, 2020 to 31st December, 2022.

Manufacturers/Permittees are requested to make necessary compliance with regards to this Alert.
